OTHER WAYS TO GIVE

Gift Planning

A planned gift can offer you substantial tax and estate planning benefits, while at the same time allowing you to make a larger and more lasting gift of education and health to VVF. There are several ways you can make a gift to VVF.

Bequest: Making a gift of cash or property by including VVF Canada in your will is one of the simplest Planned Giving options to arrange and it can significantly reduce the tax paid by your estate. Ask your lawyer how to set up the bequest.

Gift-in-Kind: A gift-in-kind is a gift of property such as real estate, securities, artwork, jewelry or collectibles. After independent appraisals, VVF Canada will issue you a tax receipt.

Life Insurance: You can make a larger gift than you might expect by naming VVFCanada as the owner and beneficiary of a new or existing life insurance policy. The premiums you pay qualify for a tax credit. When you transfer ownership of an existing policy to VVF, you receive a tax credit for the cash surrender value.
